

# Use Case Example – Solar Investments Company

### **Customer Challenge**

- Each solar project is a unique company
- Each phase of project (funding, construction, operation) rolls up to different holding company
- Need to change rollups over time

### Sage Intacct Solution

- Multi-entity structure with domestic consolidations
- Sage Intacct consolidations can run to unlimited 'books' or rollups
